

## WIOA Title I Dislocated Worker Employment & Training Activities

The President's budget proposes **\$615,485,000** for WIOA Title I Dislocated Worker, a **39%** cut to the program from current funding levels. Below is an estimate of how much WIOA Title I Dislocated Worker funding each state will lose under the President's proposal.<sup>1</sup>
